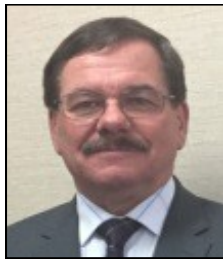
I hope you read your September minutes, we have several things going on in the next three months. Please plan to join us, bring a friend.

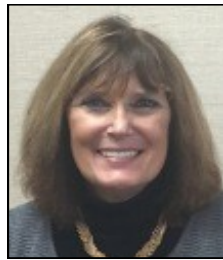
