A bill has been proposed in the Ohio House of Representatives which would prohibit any entity from retribution if a person chooses not to get the COVID-19 vaccination. It has been introduced and assigned to the Health Committee for consideration. House Bill 248 (H.B. 248)

As a result of COVID-19, there are many new possibilities for legislation and this gives the public a challenge in trying to keep up with what is going on locally, statewide and nationally. H.B. 248 has been proposed in Ohio and is currently in committee—thus, it gives each of us a chance to weigh in and express our thoughts on the proposed legislation.

You may let them know whether or not you agree with blanket coverage for both public and private vaccine exemption rights across the state. This is something that has broad implications to each resident of the state as it will impact each and every individual's health decisions and access to goods and services.
