Invocation was given by Toni Henninger at 6 p.m. Pledge of allegiance was stated. Roll call was not taken since this was an open meeting. We did have 26 reservations and approximately 30 guests.

After dinner, catered by Gloria Harpest, the speakers were introduced at 6:45 p.m. The speakers are Jennifer Gross, 1st term Ohio state representative, who introduced the HB 248; Rodney Creech, co-sponsor of HB 248; , 1st term Ohio state representative; Susan Manchester, 2nd term Ohio state representative and Jena Powell, 2nd term Ohio state representative.

Gross stated this bill is her idea and that "this is a freedom bill". Government is trying to coerce the public to get the Covid-19 vaccine. Creech said he met with medical personnel that told him government would force the public to take the vaccine and he said "it will never happen", but it is now happening. Manchester and Powell are our Ohio state representatives and they are totally supporting the bill. After presenting us with information on the HB 248, we moved on to a question and answer session. This was very open and informative. The meeting was quite successful. There were many positive comments about having more open meetings concerning current events that are happening and people want to learn about.

Business meeting opened at 8:00 p.m.

Treasurer Report: Bills presented were for Jay's Country Store of \$ 250.00 for the meal this evening and for Lyn Bliss, \$ 72.50, for printing membership hand books. Motion made to pay these bills, seconded and passed.
