Cindy Pike introduced our speaker, Carol Ginn Darke County Auditor. Carol was hired into the auditors office 35 years ago by Norma Knick and she has been auditor for 14 years. When she first started working in the auditors office, they had a manual typewriter, one telephone and payroll was done by hand. The office did 35,000 reappraisals which is now done by system fly over. A big change was the security system to the court house. In 2020 the federal government gave the office over 60 million dollars to distribute and in 2021 the office will receive over 90 million dollars to distribute which must be done by December 2023/2024. Carol gave a very informative talk and then answered some questions.

Business meeting opened at 6:45 p.m.

Treasurer Report: Checking balance is \$ 912.33; Savings balance \$ 983.00; Memorial Fund \$ 40.00. Jay's Country Store bill was presented for payment. Delores Ely made motion to pay the bill, seconded and passed.

Delores Ely is working on getting new members with a goal of ten more members than we had when Covid hit. The membership Handbook hopefully will be ready to pass out at June meeting.
