Cindy Pike introduced the speaker for this evening, Joe Braden, representing Ohio Auditor of State Keith Faber. Joe has an engineering background and is a former Mayor of St Paris, Ohio. He works with fourteen counties which has 6,000 entities he is responsible to oversee. Darke county has the most county roads in the state. The office of Auditor of State conducts audits on government money. Their motto is "efficiency, effective and transparency". Auditor's office does special audits such as fraud, performance audits, school audits and many more. They have convictions in 100 fraud cases this past year totally 1.8 million dollars. If you see/suspect fraud...report it. The auditor's office will then do a forensic audit. The systems are in place to protect us and our tax dollars.
